REPORT OF THE REGULAR SESSION OF THE SHAREHOLDERS' ASSEMBLY OF THE COMPANY FINTEL ENERGIJA AD BEOGRAD

On June 29 2023, the company Fintel Energija ad Beograd held a regular session of the Shareholders assembly. The meeting was attended by the shareholders with 25.000.000 votes out of a total 26.510.506 votes.

The following decisions were made at the session>
